The town of Wilton does not have an official partnership with the Aspetuck Land Trust regarding the Montanaro property. The Town of Wilton supported the efforts of the Aspetuck Land Trust to get a State grant by writing letters of support as required by the grant, but they did not facilitate the purchase and are not maintaining the property. They also did not provide any filing fee discounts.
