Objective

Understand how climate change will likely impact your community and implement projects to adapt and prepare.

What to Do

Sustainable CT is thrilled to partner with the Nature Conservancy to offer Community Resilience Building Workshops to municipalities. Please contact, info@sustainablect.org, for more information. If your town has already completed a Community Resilience Building Workshop you are eligible for 10 points under action 5.4.2.

1. Perform a Climate Vulnerability Assessment **(up to 25 points)**

a. Assess your community's vulnerability to primary effects of climate change, like coastal and riverine flood risk, sea level rise, and extreme temperature fluctuations. This assessment will be an expansion of what is required by the Natural Hazard Mitigation Plan process, and may be useful to include in your Natural Hazard Mitigation Plan, Plan of Conservation and Development, and/or emerging operations plan. Identify unique aspects or areas as outlined in your Plan of Conservation and Development that may be vulnerable to climate change. Create a list of priority vulnerabilities. **(10 points)**

Submit: A copy of your completed Climate Vulnerability Assessment and a completed [worksheet 1](#). **Note:** If your municipality completed a Community Resilience Building (CRB) workshop with The Nature Conservancy as offered through Sustainable CT, you only need to submit a copy of the CRB workshop report (no worksheet required).

Timeframe for Credit: Eligible for new action credit and rolling credit. This action falls under the action type "Websites, Maps, Inventories, Checklists, Assessments, Plans, Ordinances, Policies, Regulations and Resolutions (see ["Timeframe for Credit" Guidance Document](#) for submission requirements).

b. Identify how the secondary impacts of climate change are likely to affect your community. These include agricultural devastation (e.g. food insecurity), natural resource depletion (e.g. water scarcity), public health (e.g. increased incidence of vector borne disease, asthma, heat stroke, etc.), infrastructure damage or failure, and cultural resource damage or destruction. **(5 points)**

Submit: An assessment of how the secondary impacts of climate change will impact your community and a completed [worksheet 2](#). **Note:** If your municipality completed a Community Resilience Building (CRB) workshop with The Nature Conservancy as offered through Sustainable CT, you only need to submit a copy of the CRB workshop report (no worksheet required).

Timeframe for Credit: Eligible for new action credit and rolling credit. This action falls under the action type "Websites, Maps, Inventories, Checklists, Assessments, Plans, Ordinances, Policies, Regulations and Resolutions (see ["Timeframe for Credit" Guidance Document](#) for submission requirements).

c. Demonstrate that special consideration has been given to vulnerable communities (elderly, health risk, refugee, low- and moderate-income, etc.) and their particular vulnerability to impacts of extreme weather events and inability to recover and identify risks to vulnerable communities in your assessment of the primary impacts of climate change (#1 above) and/or secondary impacts (#2 above). **(5 points each, maximum 10 points)**

Submit: A completed [worksheet 1](#), [worksheet 2](#), or both to indicate where in your assessment(s) special consideration has been made. **Note:** If your municipality completed a Community Resilience Building (CRB) workshop with The Nature Conservancy as offered through Sustainable CT, you only need to submit a copy of the CRB workshop report (no worksheet required).

Timeframe for Credit: Eligible for new action credit and rolling credit. This action falls under the action type "Websites, Maps, Inventories, Checklists, Assessments, Plans, Ordinances, Policies, Regulations and Resolutions (see ["Timeframe for Credit" Guidance Document](#) for submission requirements).

2. Host a Community Resilience Building Workshop offered by the Nature Conservancy **(10 points)**

Submit: A copy of the Community Resilience Building Workshop summary of findings.

Timeframe for Credit: Eligible for new action credit and rolling credit. This action falls under the action type "Websites, Maps, Inventories, Checklists, Assessments, Plans, Ordinances, Policies, Regulations and Resolutions" see ["Timeframe for Credit" Guidance Document](#) for submission requirements.

Timeframe for Credit

Actions can either be "New" or considered for "Rolling Credit."

New Action Credit. Any action completed within the past three years (from January 1 of the year seeking certification) is eligible for potential certification points. If you are applying for recertification in your year of expiration, you may not claim New Action Credit for items that previously received credit.

Rolling Credit. For any action older than three years (from January 1 of the year seeking certification), you must demonstrate ongoing, currently relevant, and meaningful impact in your community to be considered for certification points. If you are applying for recertification in your year of expiration, you must apply for Rolling Credit for any item that previously received credit, even if it was completed within the past three years.

Why This Matters

The climate is already changing in Connecticut and will continue to do so. The sea levels have risen 8 inches since the mid-1800s and are projected to increase anywhere from 1.5 to 3.3 feet by the end of the century. Temperatures will also increase. As we experience more frequent and prolonged extreme heat days, we'll see increased risk of heat-related deaths from cardiovascular incidents, heat stroke, and dehydration. Rising temperatures also contribute to more frequent poor air quality days that will lead to premature death, acute and chronic respiratory and cardiovascular illnesses, unless we are prepared. Impacts on precipitation and intensity and frequency of storms are more difficult to predict, but trends suggest heavier rain storms and potentially more intense storms. Changes in weather patterns and rising temperatures have already contributed to an earlier tick season and increased risk of Lyme disease and other vector borne diseases such as Zika. The effects also enhance risks to the way that our residents live, work, and play. Finally, climate and weather related events can cause stress and other mental health consequences, particularly for vulnerable populations.

While multi-level partnerships are important, you are in a unique position to address your local climate vulnerabilities. The impacts of climate change will happen in your community and will require locally-tailored solutions.

Benefits

By identifying, prioritizing, and planning for your city or town's particular climate vulnerabilities, you will be better prepared to address both the immediate risks to human health and the environment, and the long-term risks to social, economic, and environmental justice within the community.

Addressing issues around climate change contributes to your community's long-term sustainability by identifying risks, protecting assets, and instituting measures that reduce burdens on future generations.
