

8.5 Collaborate With Other Municipalities

5 – 30 Points

Action Updates

Objective

Work collaboratively with other municipalities and through regional initiatives to broaden engagement and increase the impact of sustainability actions.

What to Do

1. Mentor to, or seek a mentorship with, other towns on implementation of specific Sustainable CT actions. To receive points, your municipality must demonstrate some meaningful role in mentoring to, or seeking advice from, another town(s) on action implementation. Mentoring towns can be outside of the region or state. A meaningful role of the mentor town might include: a presentation and interactive discussion about the action implementation to a committee or governing body of another town, or municipal staff time in assisting another town. Mentorship must be targeted and deliberate. For example, presenting at a conference or webinar attended by other municipalities, though worthy and important, is not eligible for points under this Action. A town can earn points for serving mentor/mentee partnerships resulting in implementation of up to three Sustainable CT actions per application. (5 points for each action collaborated on, up to 15 points)

Submit: A completed <u>worksheet 1</u>. Support given or received for each Sustainable CT action implemented must be documented separately (up to three entries per worksheet).

Timeframe for Credit: Eligible for new action credit and rolling credit. This action falls under the action type "Outreach, Education, Programs, Campaigns, Recognition/Designation in External Program, and Funding" (see "Timeframe for Credit" Guidance Document for submission requirements).

- 2. Implement Sustainable CT actions regionally Participate actively with other towns or regional organizations in the inventory, planning, or implementation of any Sustainable CT action. Active participation could include the following initiatives that support the implementation of Sustainable CT actions:
 - Mutual collection of data or inventory information;
 - Dedicating municipal staff time to drafting a joint/regional plan or policy;
 - Participation in COG regional programming that is not mandatory;
 - Collaboration with neighboring towns on land development and land use regulations along town boundaries;
 - · Participation on regional committees (such as watershed, greenway, housing, etc. committees); or
 - o Implementation of multi-town projects (such as transportation, resilience or long-term recovery, etc.).

Each Sustainable CT action completed through a regional partnership is eligible for collaboration points under this Action in addition to any points the town may receive for the action implementation. *Note:*Collaboration must occur through a joint initiative between two or more municipalities. Soft collaboration, such as event cross-promotion or conducting outreach on behalf of another municipality, does not rise to the level of a joint plan, project, inventory, policy, or program as described in the examples above. Further,

participation in a regional working group or project is not sufficient alone to earn points; it must directly result in implementation of a Sustainable CT action. (Each action completed in a regional partnership will yield 5 points, up to 15 points per town)

Submit: A completed <u>worksheet 2</u>. Each regional action must be documented separately (up to three entries per worksheet). Regional plans must be adopted in the municipality requesting points.

Timeframe for Credit: Eligible for new action credit and rolling credit. This action falls under the action type "Outreach, Education, Programs, Campaigns, Recognition/Designation in External Program, and Funding" (see "Timeframe for Credit" Guidance Document for submission requirements).

Timeframe for Credit

Actions can either be "New" or considered for "Rolling Credit."

New Action Credit. Any action completed within the past three years (from January 1 of the year seeking certification) is eligible for potential certification points. If you are applying for recertification in your year of expiration, you may not claim New Action Credit for items that previously received credit.

Rolling Credit. For any action older than three years (from January 1 of the year seeking certification), you must demonstrate ongoing, currently relevant, and meaningful impact in your community to be considered for certification points. If you are applying for recertification in your year of expiration, you must apply for Rolling Credit for any item that previously received credit, even if it was completed within the past three years.
