Additional Information: Kelsey Wentling from the CT River Conservancy discussed two invasive and destructive aquatic plants that are taking over the CT River: Hydrilla and European Water Chestnut. She shared images of these plants in the CT River, discussed their distinctive features, their growing season and their propagation pattern. She discussed efforts by the CT River Conservancy to track the spread of these plants through an online website reporting system, as well as the Conservancies efforts to suppress these plants through various means, including bariatric plastic mats placed on the floor of the river to prevent plant growth. This year, Pamela Roach (Rocky Hill's Consultant) and Mona McKim, Director of Finance worked with Amy Thompson at UCONN through Sustainable CT to be sure all municipal buildings were being tracked, to gather addresses for schools, provide CNG account numbers for both municipal buildings and schools, and verified that town/school buildings use natural gas and do not use oil or propane. Pam and Mona held several zoom meetings with Amy and her assistant Jin, Andre in an effort to collaborate to be sure data entered was as complete as possible. Amy and Jin entered data into ENERGYSTAR Portfolio Manager for Rocky Hill. Additionally, Rocky Hill is scheduling a training session on how to use the energy portfolio: navigating the portfolio, updating manual data going forward and running new quarterly reports going forward.
