Attachment 1 includes a summary of all preserved land in Mansfield as of August 1, 2019. In June 2018, the town purchased the 114-acre Simpson-Wood Preserve with the assistance of a CT DEEP Open Space and Watershed Land Acquisition Grant. In January 2019 the Town accepted a donation of a 1.18-acre parcel, Hanks Corner Preserve (Attachment 2 includes minutes from the Mansfield Town Council Meetings where these acquisitions were authorized). Acquisition and management of open space properties are guided by the Town's Planning, Acquisition, and Management Guidelines for Mansfield Open Space, Park, Recreation, Agricultural Properties and Conservation Easements (Attachment 3), which includes standards to encourage sound transactions, proper documentation, and responsible stewardship for all Town-owned land. Chapter 3 of the 2015 Mansfield Tomorrow Plan of Conservation and Development (Attachment 4) provides a detailed summary of Mansfield's Open Space, Parks and Agricultural Lands and goals and actions for the future. Appendix C (Attachment 5) identifies a series of criteria used to evaluate proposed open space acquisitions based on planning, historic, habitat, water resource, agriculture/forestry, scenic, connectivity, and recreational values. Attachment 6 is a copy of the Open Space Fund.

Additional Information: The Flaherty Road project was completed in 2017 in order to make the road more walkable for pedestrians. Similarly, the Eastwood Road Walkway project is being designed to make the road more accessible to pedestrians. The final design was created in April 2018. The Maple Road project is still in progress; a concept report was prepared in April 2019. According to the concept report, "the purpose of this undertaking is to provide safe road cross section for the combined use of vehicles, cyclist and pedestrians (Complete Streets). The project will be considered in whole as well as prioritized sections based on substandard elements." A walkway on Route 89 is currently being worked on in conjunction with the Safe Routes to Schools program. The final design was completed in January 2019.


