Documentation Details: Action 2.1 Overview document outlines submission Each year, the Bristol Water Department provides tours of our Water Filtration Plant to all 6th grade students from Bristol Schools. The tours are conducted by staff from the Environmental Learning Center located in Bristol and are done in coordination Board of Education's science curriculum. In 2018, the water cycle of the science curriculum was moved to 5thgrade and tours were changed to 5th graders. In the tours, students learn the entire Water Cycle including how watersheds play a critical point in providing safe drinking water. Hands on stations allow students to see how run off from pollutants can impact a watershed and what they can do to prevent it. Students also see the entire water filtration process from raw water entering the plant to discharge of potable water. The students are also educated about the need to use water wisely so that the precious natural resource can be sustainable. Students are provided with water bottles to help reduce plastic waste and toilet test kits to help reduce water consumption at home. Additional Information: An example of a priority historic resource and actions required to sustain its long term viability is found at 5 High Street, the Main Street Public Library. Upkeep and management of this facility is under the domain of the City of Bristol Department of Public Works. Long term Capital Improvement Plan inclusion is required to insure the current conditions are maintained and larger, high cost improvements and equipment replacement is planned for well in advance. The structure underwent a renovation and expansion in 2006. At that time, new boilers, roof-top air handling units, and elevators were installed. In July 2018, the exterior painting on the historic wing of the Main Library was stripped and re-painted, with funding assistance from the State of CT. 7/15/20 Update: The City of Bristol operates on a Fiscal Year that runs from July 1st to June 30th. Currently, an EPDM roof replacement is starting at 51 High Street for the sum of \$42,900 and being completed by Premier Building Associates of Branford. Other projects to be completed during FY20-21 is the restoration of vestibules that serve entrances along Bellevue Avenue at 51 High Street, budgeted for \$30,000. The City will also be completing a facility wide exterior painting project, which will be handled as an EPA RRP (Renovations, Repair & Painting) project, as lead-based paint has been found during analytical investigations prior to work start. Finally, the City has been awarded at \$17,500 grant through the State Office of Preservation for the abatement and repair of interior wall plaster in the historic wing of the Main Library at 5 High Street. The plaster contains detectable levels of lead in painted surfaces and a contained abatement will be required for removal and disposal, prior to plaster wall repairs.
