Bike Walk CT - A major partner to both the City, and our local bicycle advocacy group, Bike New Britain.

Together we've partnered on a number of events from our annual child and bike safety focused "Bicycle Rodeos" to our annual National Bike to Work Days events, and 4 year partnership on the Discover CT Bicycle Tours which have been based out of the New Britain Museum of American Art in 2019, 2018, 2016, and 2015.

Several citizen and stake holder working groups were also involved in the implementation of the City's Complete Streets Master Plan, Bicycle Connectivity Plan, and planning for projects like the Beehive Bridge.

Additional Information: Working with Alyssa Norwood, the City's Director of Public Works, Mark Moriarty, served as the co-chair of the transportation working group that helped determine the sustainable transportation related criteria that municipalities would need to satisfy to achieve Sustainable CT recognition. All of the meetings held to discuss and determine this criteria where held right in New Britain City Hall. Director of Public Works Moriarty still also serves on the Sustainable CT Municipal Certification Committee.
