Additional Information: Falls Village is a 99% Caucasian town. We wanted to both support our nation and the Black Lives Matter movement and explore how our beliefs and actions may be contributing to the lack of diversity in our town. We were fortunate to have a resident who is both African American and a certified anti-racism facilitator. She modified a program that she has been doing for twenty years for our town. We spoke with our town library about having a prominent display of both literature by non-whites and specific anti-racism titles available and prominently displayed in the library. We also requested that the library make a DVD available RACE: The Power of and Illusion for check out. We created a survey, that can be done anonymously or can be returned with name and contact information, for all residents. This was designed to get a better understanding of our community and provide an opportunity to participate in an Equity Workshop if desired. The survey contains instructions for both self-study or group study. We held a number of workshops with small groups 4-8 people following their review of the DVD. Carol Taylor served as the facilitator. This work is ongoing, and we now have a young woman who is assisting Carol in facilitating the workshops.

Partners: The Town worked with Kellogg Elementary School to develop and promote a garden. This garden is used for educational purposes by the school and is maintained by students and other community members.

Additional Information: This garden is a "Three Sisters Garden" poly-garden, which means the items grown together support each other and don't compete for soil nutrients. Corn (Popcorn), Dry Beans and Pumpkins were planted, nurtured and harvested. The municipal involvement was use of town owned land. Farmers from the Adamah Farm at the Isabella Freedman Retreat Center in Falls Village helped the Kellogg School children maintain the garden. The produce was sent home with the Kellogg School children for them to enjoy with their families.

Documentation Details: The town presented its housing data at an open municipal meeting to the public to determine a plan moving forward for Town Projects in 2020. Residents were given an overview of the housing and population demographics, and presented with different options that they could want the town to move in, form fiber-optics to affordable housing. The data and presentation from that meeting has been attached here. The attached worksheet is a brief overview and analysis of the housing data of Falls Village and notes the amount of affordable housing in the community. Falls Village created a 501.c.3 Falls Village Housing Trust in 2016 Board Biographies attached. In 2020 we applied for a grant to hire a facilitator to assist us with the state mandated Affordable Housing Plan. Our draft plan to submit to P&Z will be ready by the end of 2021. Attached is a list of the Task Team members and Agendas from our meetings to date. We placed a notice around town and in the local paper to expand the group and bring in new and diverse members.

Additional Information: A group of Falls Villagers has been working diligently to create affordable rental housing in our town. We are very aware that the lack of smaller rental units is contributing to our young people moving away and our seniors living in unsafe and expensive homes. We are deeply engaged in working with the community to address the implicit bias that is a barrier to swift development of urgently needed affordable housing.

11.2 Grow Sustainable and Affordable Housing Options

This began with creating an Incentive Housing Zone (IHZ) to allow for the first multi-family development in our town. The town received IHZ incentive funding from the Department of Housing that it dedicated to this project. The Falls Village Housing Trust Inc. has raised funding through grants, donations and financing for the Site Work, Architectural and Engineering Plans.

Documentation Details: 11.2.3 Narrative on the funding process where funds were secured and the town acted as Fiduciary manager and distributed funding to Falls Village Housing Trust.

Partners: The Falls Village Housing Trust, Inc.(FVHT) was formed in 2016. In 2018 it received 501.c.3 non-profit status. In 2018 the FVHT received grants and financing and completed some site work. In 2019 architects were interviewed and a selection was made. Throughout 2019 and 2020 site work was done and architectural and engineering plans were developed. The Town administers funding to this Trust. Throughout 2020 Town meetings occurred and various local agencies (Wetlands Commission, River Commission, Fire Marshal, Planing & Zoning) signed off on the project. Site work will begin in Fall 2020 and construction will begin Spring 2021. Additional partners are: Housing Enterprises, Northwest Hills Council of Governments, NWCT Regional Housing Council, PSC, LISC, SustainableCT

Additional Information: The Town of Canaan (Falls Village) applied for the Community Development Block Grant (CDBG) in June 2021. We expect to hear back by the end of the year. This large funding package will be used to complete the infrastructure for River Road Homes. This is another financial partnership where the Town is Fiduciary and the Falls Village Housing Trust is the recipient.
