Partners: 10.4 (Developing Community Growing Spaces) The Town of Washington provides steady, consistent, and multiple forms of support to Judea Garden. SRA volunteers distribute food to residents in need from the steps of the Bryan Memorial Town Hall every Monday from 11:45-5:00 pm from July through October. Residents interested in signing up for distribution can contact SRA, social services, or the First Selectman's office to receive produce. The Senior Center regularly informs our older residents in need and the Assessor's office sends inserts about Judea Garden to residents eligible for state programs. Washington Community Fund and Washington Garden Club provide funding for two internships per summer. Region 12 schools (Washington Primary School and SHepaug Ag High School) start seeds, help plant and weed the garden, and conduct special projects. Boy Scouts local troop had an Eagle Scout build composting bins as part of his Eagle Scout initiative. Gunn Memorial Library and Five Senses Festival also host programs and readings at Judea Garden.

(8% of total pop) and a survey of workers to which we got 96 responses. 11.1.1- The Power Point from our Feb 8th housing meeting outlines some of our Communication Strategy. Pg. 6 shows where we discussed how were were going to advertise our forums to increase public participation.
