**Additional Information:** This is a new action initiated by the school with our support, but it builds on previous ant-idling work described here. Past anti-idling campaign: The Ashford Clean Energy Task Force has been the face of the anti-idling campaign in Ashford. In late 2017, the Task Force purchased anti-idling signs to be placed at strategic locations in town. In December 2017, the First Selectmen approved the placement of signage at the Ashford Transfer Station. In an effort to continue to spread information about the state legislation and promoting cleaner air, members of the Task Force attended other town meetings to discuss anti-idling. Members attended a Board of Ed meeting and also provided anti-idling program information to the Eastford Clean Energy Task Force. An idling info card was been included in the town's monthly newsletter, the Ashford Citizen.

Additional Information: COMMUNITY GROW SPACE - The beautiful Ashford Town Gardens are located on the green space in front of the Babcock Library and the Ashford Town Hall, across the road from where the Ashford Farmer's Market is held. They are in the center of town, so that anyone visiting these municipal locations, or just driving by, can't miss the colorful display. Something is always in bloom all season long. The gardens include two large kidney gardens, a flagpole garden, a pollinator garden (which was refreshed this growing season) and a long bed along the fence in front of the library. There are seating areas in the grounds and many town events happen there - it's our town green. The gardens are planned and maintained for the benefit of the community by the Ashford Garden Club. The club, which currently has 76 members, actively solicits new members, so all residents are encouraged to join and participate in the effort. Ashford Garden Club communicates with the community via their public facebook page and via Ashford Community Connections on facebook, and by distributing fliers at community events. Attached is their current flier, which describes their commitment to community enrichment, and includes pictures of two of the gardens. Attached are additional pictures of the gardens, flanked by the Town Hall and the Library. The kidney gardens are primarily perennial flowers, with annuals added for pops of color. The pollinator garden is filled with native plants, such as goldenrod, milkweed, indigo, etc. In addition to beautifying our town properties and inviting the public to join, the Ashford Garden Club encourages gardening throughout the community. They have made seeds available for residents who want to plant flowers at home. As part of Ashford's tricentennial celebration on the town green, the Garden Club gave away juneberry saplings (a native, early-blooming shrub/small tree), so that the town will be in bloom at the same time in the spring, extending the growing to personal property. This summer the Ashford Garden Club, when thinning out perennials in the kidney gardens, offered free plants to residents to take home and plant. The Ashford Town Gardens are a vibrant and beautiful reflection of our lovely, welcoming and caring Town of Ashford. They are maintained by residents for of the town for the benefit of the entire Ashford community. Much like a community vegetable garden, participation is voluntary but open to all.
