Partners: 1.1 (Optimize for Equity): The Goshen First Selectman took part throughout the process. in addition, representatives of the following town commissions, committees and non-profit organizations provided input: Library Board of Directors, Friends of the Library, Board of Directors for Recreation Dept., American Legion, Historical Society, Volunteer Fire Department, Garden Club, Lake Weed Committee, Planning & Zoning Commission, Inlands & Wetlands Commission, Water Pollution Authority, Goshen Land Trust, Community Care and Hospice, Farmers' Market, Goshen Agricultural Council, Housing Trust, Goshen Business Circle, Economic Development Commission, Goshen Good Neighbors, Center School PTO, Goshen Fair, Goshen Recycling & Trash Comm, and the Goshen Running Club.

Additional Information: As a small town, Goshen has less resources to support communication between town government and its residents. This has always been a struggle. A great deal of work is accomplished with a few full time and some part time employees who all wear many hats. We understand the importance and urgency of this action's goal of: "Build and strengthen municipal processes to be more inclusive, cohesive, and representative of all community members, now and in the future. These systemwide, structural changes are an important step in creating open and equitable communities." and we have welcomed the opportunity to work to improve on this. There is irony in using a vehicle to identify a town's need and determining the need is to improve the vehicle. While there are many areas we hope to work on to make Goshen a more welcome, healthier town, we have determined that first we must improve the ways we communicate with residents and increase the ways that residents can respond to the town. Our work has begun on this via Category 8.2 Provide Effective Community Communications.

Documentation Details: The Goshen Business Circle, with over 95 members, is an organization that works closely with the town Economic Development Commission to promote local entrepreneurs, products, and service providers. The government appointed EDC shares members with the GBC and both work to improve the business environment in town. The Business Directory was compiled from the members of the GBC and each are featured on the GBC website (#1). Residents can access it from our town website as the "Business Directory" from the home page and on the Economic Development Commission page. The Goshen Business Circle has a Goshen Business Locator map that color codes type of businesses and links to each business's website/Facebook page, per their preference. Since many businesses in our small town are run out of homes and are services that are rendered at the place of service, only businesses who meet with customers or clients at their addresses are on the business map. Screenshots and links to the directory and map for both the directory and map are in the second document. The Goshen Business Circle members, town hall, and post office display (#3) the GBC's 8.5 x 3.5 flyer that directs residents to their website, which also a community event calendar.

Documentation Details: The Goshen Conservation Commission revised the Goshen Open Space Plan in 2015 (#1) and use it as a basis for their work. They have referred to it in addressing questions sent to them from Planning and Zoning Commission and at every meeting. The minutes of their August 2022 meeting (#3) show the Commission's work for the town addressing recreational use of ponds and lakes, promotion of pollinators, and support of agriculture. The document is also a source for the Goshen Land Trust, a non-profit organization that shares two board members with the Conservation Commission and uses the Open Space Plan in its work to prioritize properties for acquisition.

Documentation Details: As a rural town the identification and eradication of invasive plants is a constant concern. The town Conservation Commission and Goshen Land Trust work together frequently using the Town Topics, a newsletter mailed four times annually to all residents, to educate residents (#1) as in the articles in the Spring 2022 edition when aquatic and terrestrial species were the focus. The Goshen Land Trust's website, which is linked to the town website, provides residents with information on identification and control of invasive plants. In July the Conservation Commission, Goshen Land Trust and Sustainable Goshen Team organized an in-person Invasive Plant Workshop that was announced via an email (#2: Email Invitation to workshop) and website announcement (#3). A flyer (#4) was distributed in public areas in town and shared with Goshen Land Trust members. The presenters were members of the Conservation Commission and Land Trust. After a walking review of the town property known as Camp Cochipianee ten terrestrial and four aquatic invasive plants were identified (#5), members of the trust and commission volunteered to be presenters for each species. The workshop was attended by 20 residents (#6). Participants were given a packet with a list of the species that would be discussed along with information sheets (NOA) for each. An additional information sheet was provided (#7) giving step by step instructions for the Cut & Paint eradication method. During the 2 hour workshop participants walked the 1/4 mile trail where presenters gave demonstrations on how to recognize and then methods to control/eradicate species. Besides cut and paint demonstrations were given on cutting and removal, using a weed wrench, and pulling/hanging or removal. Tarping was discussed. A follow up email thanking participants for being a part of the workshop included a recent CIPWG powerpoint (#8) of CT's 10 most invasive plants calendar for removal as a resource. This link was added to the Sustainable Goshen website which is linked to the town. Photos of the event and screen shot of the resources are included in the final attachment (#9).

Partners: 3.10 (Facilitate Invasive Species Education and Management) The Town's seasonal publication provided a platform for a non-profit (Goshen Land Trust) and town commission (Conservation) to coordinate an educational opportunity for all residents. The town Conservation Commission and Sustainable Goshen along with resources provided by the Goshen Land Trust held an Invasive Plant Workshop for all residents.

A map of the current and proposed pollinator gardens in Goshen (#5), a Pollinator Garden Overview (#10), an introduction to the Goshen Monarch Sanctuary and new Pollinator gardens (#8), and Educational outreach flyer (#11) from the Farm Tour 2022. 3.12.3 Pollinator Pathways signed Resolution (#3) and the minutes to the two Board of Selectmen meetings (#2 and #4) when the resolution was discussed, amended and approved.

Partners: 3.12.1, 3.12.2, 3.12.3: Many people and organizations have worked to recognize Goshen's potential as a Pollinator Pathway. The Goshen Agricultural Society provided the land for the Monarch Sanctuary and first pollinator garden. The Goshen Conservation Commission worked with the Goshen Community Garden to coordinate an exhibition Pollinator Garden at the Town Hall, The Goshen Congregational Church sponsored the Community Green Garden where the first pollinator garden and Monarch Sanctuary are located. And Sustainable Goshen Team helped promote the work, with the Goshen Public Library by distributing Pollinator Garden seeds to residents at the Goshen Wellness Day, Goshen Climate Crisis presentation at Goshen Center School and the Goshen Farm Tour 2022. In addition the following organizations offered support, information, or volunteer hours: Goshen Land Trust, Litchfield Land Trust -(John Markelton), Xerxes Society, Northwest Conservation District (Karen Nelson) and Monarch Watch members.

Additional Information: Goshen Board of Selectman have signed the Pollinator Pathways Resolution which will be followed by the municipal groups in town for the future and a plan to work with residents and the town to extend the pathway from Litchfield in the south to Norfolk in the north.

Documentation Details: In 2012 the Town of Goshen adopted a Right to Farm Ordinance that continues to provide guidance for the Planning and Zoning Commission, the Town Planner and the Goshen Agricultural Council (a town commission) to work together promoting agriculture as an economic and cultural focus of Goshen. The documents include the Right to Farm Ordinance, minutes for a Goshen Agricultural Council in December 2019 (due to the pandemic the group did not meet in 2020-2021) illustrating their work to promote farms in Goshen as well as supporting agricultural land purchase/use in the town. In February 2022 a new property owner brought a request for a permit to the Planning and Zoning Commission (Minutes 3-22-22) for a farm store. The minutes show a referral to the Goshen Agricultural Council, which called for a special meeting/public hearing held on April 4, 2022 (Agricultural Council Agenda 4-4-2022).

Partners: 5.3 The Goshen Agricultural Council works with the Planning and Zoning Commission, Economic Development Committee, Board of Selectmen and Town Planner as well as state agencies, such as the Connecticut Department of Energy and Environmental Protection and the Connecticut Farmland Trust to expand farming opportunities in the town.

Documentation Details: 6.5.6 Promote Public Transit and Other Mobility Strategies: Provide shared mobility services #1: On second paragraph of page 2 the minutes for the July 21, 2015 Board of Selectmen's meeting explains the grant award for the town of Cornwall and Goshen to purchase a "handicap van". #2: On April 27, 2015 the Goshen Board of Finance explains the purchase arrangement of a 12 passenger van on Page 6. #3: March 29, 2016 Board of Selectmen minutes documents the Board of Finance approval of payment of \$7000 for Goshen's portion of the van. The fourth document (#4) shows current data of use. The van is available for hire by seniors and those with handicaps preventing them from self-transport for use to go to medical appointments, shopping or other transportation needs. The data shows use of the van by Goshen residents from July 2019 to June 2022. In addition, the Goshen Community Care and Hospice continuously provides rides for residents without transportation by volunteers using their personal vehicles and to monthly lunch and recreational outings using the 12 passenger town van. As a small town of only 3150 residents (2020 census) with no public transportation, the work to obtain a grant collaborating with a neighboring town in order to provide residents who need help and then insuring that financing continued to be directed for maintenance and use shows Goshen's dedication to our residents. The 'summary of Goshen ride data' document illustrates that the van continues to be a source of support to residents who need it - even during the height of the pandemic when many seniors and adults with disabilities avoided leaving their homes.

Partners: 6.5.6 Promote Public Transit and Other Mobility Strategies: Provide shared mobility services: The town of Goshen purchased and continues to maintain the van with the Town of Cornwall. A partnership with Geer Village Senior Community provides for a 24 hour call service to enable all residents of both towns to have easy access.

Documentation Details: Goshen Sustainable Team held its first Sustainable Event on June 3, 2022. The invitation to the event (#1) was emailed and hand delivered to those on the list of residents/groups identified by the Sustainable Goshen Team that would provide a substantive cross section of all residents. #2 is the slide show that was used to introduce Sustainability CT, the five presented projects, and the instructions/questions for table discussions and work. #3 is the sign in used that evening, #4 is the sign placed at each table. Participants were randomly assigned a group to work with in order to encourage new ideas. #5 is the Word Cloud generated from all table responses to the question: "what do you love about Goshen?" and #7 is the culmination of table response for the prompt "Goshen would be even better if..." All participants completed an exit ticket (#7) allowing the the opportunity to suggest people we had not included and ideas they wanted to insert or amplify. A second group of Sustainability Events began on April 2nd at the Goshen Health and Wellness day (#8), repeated on April 27th at the Center School/Public Library Earth Day and ended at the Goshen Farm Tour August 6th and 7th (#9-10) where members of the Sustainable Goshen Team met with residents and tourists to talk about the importance of sustainable practices, explaining Sustainable CT, sharing information on the need for Dark Skies with distribution of Lights Out, Goshen! flyers and distributing Pollinator Garden seed packets (#11). Worksheets for both events are included as documents #12 and #13, respectively.

Partners: 8.1 (Sustainability events) Sustainable CT helped facilitate the Community Conversation, Goshen Board of Selectmen helped promote and presented at this event, Members from the following attended the June 3rd event: Public Library, Friends of the Library, Parks and Recreation, American Legion, Historical Society, Volunteer Fire Dept, Garden Club, Lake Weed Comm, Planning & Zoning, Inlands & Wetlands, Water Pollution Auth., Goshen Land Trust, Community Care and Hospice, Farmers' Market, Goshen Ag Council, Housing Trust, Goshen Business Circle, Economic Development Comm., Goshen Good Neighbors, Center School PTO, Goshen Fair, Goshen Recycling & Trash Comm., and the Goshen Running Club. Documentation Details: The Goshen Green Garden started in 2014 as a project of the Goshen Church of Christ Congregational. Since then it has evolved into a Goshen wide and town supported community garden. The Goshen Town Topics is a Board of Selectmen publication mailed to every resident four times a year. Announcements for garden lots available, produce that has been donated to local seniors and soup kitchens/homeless shelters in nearby Torrington, and supported by the Goshen Agricultural Society. Included in the document are articles for the garden from Summer 2017, Fall 2018, Fall 2019, and Fall 2020. Photos included are of the garden community plot, produce ready for senior pick up/delivery, and produce ready to be delivered to the soup kitchen.

Partners: 10.4 The Goshen Green Garden is managed by volunteers. Originally they were primarily from the Goshen Church of Christ, however in the last two years the Town of Goshen has supported the garden via the Town's Farmers' Market and Parks and Recreation Department. All town residents can adopt a lot at the garden and four community gardens grown vegetables and fruit to be distributed to seniors and food banks (Friendly Hands, FISH (Friends in Service of Humanity), and the Community Soup Kitchen.

Documentation Details: 11.1.1 The Coshen Affordable Housing Committee (#1 members are listed and their titles/sector) had its first meeting on December 17, 2020 (#2 Minutes and Powerpoint). A representative of the Northwest Hills Council of Governments provided demographic and housing data for the committee and acted as facilitator at their two Public Forums and throughout its nine months of meetings. Meetings were open to the public via Zoom in in-person when state covid restrictions allowed. The Affordable Housing Committee April 13th minutes detail discussion of the committee preparing for its first forum anticipating questions and reviewing data to be discussed (#3). 11.1.2 The Housing Data Profile (#4) and Population Age data (#5) were analyzed in Worksheet 2 (#6). This data was shared and was the basis for the work of the Affordable Housing Committee. 11.2.3 The Goshen Affordable Housing Plan (#8) was completed September 2021 after a second Public Forum August 2, 2021 was conducted via Zoom for public input. Worksheet 3 (#7) breaks down the plan. At the Goshen Board of Selectmen's meeting on October 5, 2021 (#9) the plan was adopted and referred to the Planning & Zoning Commission. The plan is available in hard copy at the town hall, was emailed to all residents and is currently available as a download from the town website (#10).

Partners: 11.1 (Design and Implement an Affordable Housing Plan) The Goshen Affordable Housing Committee and Board of Selectmen worked closely with the Northwest Hills Council of Governments throughout the process of writing the Affordable Housing Plan.

Additional Information: The Coshen Housing Trust, a 501(c)3 organization incorporated in 2011 to address the unmet needs for affordable housing. Currently the Trust is renovating a small apartment complex in Goshen to provide affordable housing for residents. While the town has adopted an Affordable Housing Plan there is more work to be done to provide diverse attainable in Goshen.

Documentation Details: 12.3 Collect and Share Homelessness Data: The NWHCOG report (#1) on Homelessness was generated by our area (Northwest Hills Council of Governments) Rural Healthcare Resource Coordinator. After meeting with him and reviewing his report we shared the findings with the town Board of Selectmen (#2) and initiated ways to improve educating residents and state resources that are available. As Mr. Ghio explains, there are no residents of Goshen who have identified as homeless via the 211 network. Anecdotally we know that residents who are food insecure or lack transportation have many town resources to help them. Home insecure residents, because our town is so small (pop. 3150) have a high likelihood of being offered assistance via the many non-profits, church or by a neighbor. We explain this further in 12.4.
