The flowers are grown at one of the farms in town. These are all represented by people who care about the beauty of our new building. Andover is extremely proud after many years to have a new Community & Senior Center. Plans are currently being made for a sign to go in front of the building letting everyone know its name. Originally we did not have enough money to outfit our kitchen but with a grant and extra funds set aside it is in the preparation stage and should be completed by the fall of 2025. A committee appointed by the Board of Selectmen (BOS) is searching for a Director to run the Community & Senior Center Building. In the meanwhile, we have an excellent temp director putting plans in place for seniors.

Partners: 1.1 Many people were responsible for the help of the new Community & Senior Center Building. Our building committee, Town of Hebron, Town of Columbia, Town of Lebanon - all three directors invited the committee to come and view their buildings and to ask questions about what was needed to build an appropriate building for seniors. All three directors were especially helpful with handicap entrances and best way to help seniors with their needs. Andover Town Administrator, Board of Selectmen, Public Works Foreman, Architect and Engineers were all strong supporters and helpers in this project.

Additional Information: Tourism is a new concept for the Town of Andover and this should be viewed as an ongoing new project. We are looking forward to see Andover published in the state tourism brochures. The EDC Chairman is constantly working on this new concept to get Andover involved in the state tourism. Before we had our covered bridge and before our Monument Park was constructed we never felt the need to become involved in tourism as we did not feel we had anything special to offer from our town. Many people are working to reconstruct the image of our town to make it more tourism worthy. 4.1.3 Written Summary 5 points 1. Andover belongs to the Northeast Tourism Board and the CT Visitors board which is the state tourism board. Andover has representation in the Northeast Tourism guide annually and our EDC Chairman has been working to get the Agent Orange monument mentioned on CT Visit guide. The state meets quarterly and the Northeast Board meets monthly. EDC sends information to be published directly to both boards and the chairman attends meetings. 2. Since Andover has the Rail of Trails and the only covered bridge in the United States that crosses over land and not water we feel that will be published as a point of interest to visit when traveling through CT. 3. The Veterans Monument Park is a huge focal point for those driving through Andover. The Park now has lights installed on the monuments to enhance the beauty and meaning of these monuments. A brick walkway has been constructed so those visiting have easy access to walk to the Agent Orange Monument and the Missing In Action (MIA) monument. In the summer a new Battlefield Helmet Monument will be placed at the site. It is to be noted that in the entire United States there are only four (4) Veterans Memorial Parks that feature these monuments, Andover is extremely pleased to be part of this park. Two stone benches will be constructed for the site this summer. The BOS, Town Administrator and other officials sponser this park to keep it running smoothly. Many residents come down and walk through the park and look at the stones as they each are in honor of a fallen veteran. 4. Andover Sustainable CT has created a community garden in back of the Town Hall and that will be a cultural asset to our town and residents in 2022. We would like to see this information placed in the CT visitors brochure so that people will come to Andover and see what the town residents have created
