These organizations include Coalition for a Sustainable Cheshire, Cheshire Creation Care, First Church Eco Action Team, Friends of Boulder Knoll, and Quinnipiac Valley Audubon Society, among others. 3.12.2 Pollinator Pathways, create a garden: We partner with the Town of Cheshire, who has given us permission to have these gardens on Town property. We also partner with Cheshire Parks and Rec and Cheshire Public Works, who help us by mowing, removing debris, and providing access to water for the gardens. We are always happy to partner with students looking for community service hours and businesses doing community give-back days.

Additional Information: These are serious pollinator gardens, with native spring ephemerals, native perennials and native shrubs. We also plant bright, attractive annuals along the edges of the gardens. These attract pollinators, and also show the public that native plant gardens can be attractive. Additionally, we had several other events over the past year: Kelsey Fisher did a program on Monarch Butterflies in 5/2024, a Citizen Science Native Bee survey was done with The CT Ag Exp Station 2024 by Dr. Breahna Gillespie, and we had a zoom presentation with Heather Holm (4/2024) about native bees

Documentation Details: 9.4.1 - Cheshire Public Schools Food Waste Diversion Program: Attached are meeting minutes from the Town Council's Sustainability Committee--the minutes from 8/5/2024 provide an overview of the food waste diversion program pilot that began in January of 2024 at Chapman Elementary School. The minutes from 6/17/2025 provide an overview of the expansion of the food waste diversion program to Doolittle Elementary School and a proposal for expanding further to Dodd Middle School in Fall of 2025. The CPS Compost program handout provides an overview of all three school programs that have been supported with NEF funds. 9.4.1 - Boulder Knoll Farm Compost Facility: Boulder Knoll Farm attended the 1/21/2025 Town Council's Sustainability Committee Meeting (agenda attached) and shared a proposal to build a public community composting station where Cheshire residents can compost their food waste. Boulder Knoll Farm is a local non-profit that operates community gardens on town-owned land. Also attached are minutes from the 2/11/2025 Town Council Meeting, where the Town Council voted 5 to 1 to support using \$5,000 of NEF funds to support Boulder Knoll Farm in building the public community composting station (see agenda item letter I). The station will serve as a pilot to assess community interest in and support of food waste diversion. The final 3 documents contain pictures from the compost facility, which opened to the public in April 2025.
