Documentation Details: 12.3 Regarding the Essex Affordable Housing Plan, under the statute CGS 8-30j passed in 2017, Connecticut communities are required to create and adopt an affordable housing plan by June 2022 and update it every five years. Essex submitted its preliminary plan in March 2019. A public meeting was called on March 17, 2022, to begin to finalize the plan to reflect Essex's current priorities and values. The attached Town of Essex Affordable Plan details the housing stock available in town as well as the populations who are considered "cost burdened",i.e., those who spend more than 30% of their income on housing. In Essex 1,019 households (34%) qualified for low-income housing. According to the Consumer Price Index (CPI), as of February 2022 the CPI increased 7.9% year on year, increasing the cost burden on low-income families who could potentially face homelessness in the years ahead. For the years 2023-2025, the rate of increased slowed, but the big jump in 2022 affected prices in the ensuing years Please see pages 34 and 45 In the attached publication. ---
