Documentation Details: 7.1.1: Goodwin school has low energy usage because it is no longer in use. Vinton school and Goodwin school were both closed and all elementary school children go to Mansfield Elementary School as of 2023. Although Vinton and Goodwin are not completely unused therefore they still use some energy. The Mansfield Historical Society (MHS) is not a town entity, it is a privately owned non-profit. The Old Town Hall that the MHS occupies is a town facility. MHS pays for their own electricity and is not part of the towns footprint, but the Town of Mansfield pays for their fuel. The Mansfield Elementary School solar was installed in January 2023, we do not have accurate readings of the solar until April 2023. The building was also not fully functioning and did not hold any students until it opened on April 27, 2023.
