Documentation Details: 3.1.1a - There were several education programs to teach the public about watersheds. The first was a 5th grade field trip on 02/25/23 to the water and sewer departments. An email setting up the field trip is included in the "Water and Sewer Department Field Trips" document. This trip was offered again 0 n1/31/24. A second activity involved students from Eastern Connecticut State University and addressed drinking water management. To mark National Water Week in May 2024, special pages were added to the Water Works website that included printouts, games and other learning materials for the community. The ongoing outreach campaign covers flyers and manuals disseminated to the community. This includes the rest of the documents, including the 2023 Windham Water Works Report. Manure Management Manual, Agricultural Manual, and Agricultural Waste Assistance Flyer, 3.11b Windham Water Works oversees a large watershed, including Mansfield Hollow Lake. It has instituted a signage program there to protect the water supply. These signs were installed in 2024 and are inspected annually (3.1.1b Additional signage 2024). In addition, it works with landowners and residents in this area (Protecting Watershed, Septic Systems).

Partners: 3.1.1a - Windham Water Works and the Town of Windham Water Department helped host the 5th grade field trip, with local, state officials, and other interested parties joining in on the trip. They have hired an Environmental Technician who interacts with the Town Sustainability and Energy Committee on our common interests.

Documentation Details: 3.2.1a- The "Natchaug Healthy Watershed Protection Plan" describes the general characteristics of the watershed in Section 5.8.6 (pl0-15). Section 12 (p30-92) which describes the Protection Plan's recommendations, also includes a more detailed inventory of the watershed. A map showing possible locations where pollutant loads may enter the watershed can be found on page 44 of the plan. An additional map (3.2.1 watershed pollutant entry map) is also included. The Natchaug Healthy Watershed Protection Plan is still active and used in 2025. 3.2.1b - The Plan contains maps of water resources on pages 12-15. 28, 33. While the Plan is more than 3 years old, regular review by the WWW ensures its currency. An additional map 3.2.1b Mansfield Waterways has been included. Windham's Watershed Protection Goals are summarized on p9 of the Watershed Protection Plan, and aim to "protect high-quality waters, other natural resources and the watershed services they provide to local communities" with a focus on "reducing non-point source pollution, particularly nutrients". They align with those developed by the CT American Water Works Association (3.2.2 Watershed Inspection Guidelines). The approaches to addressing them are shown in 3.2.2 Watershed Inspection Program, including the forms used to monitor water quality in both upstream waterways and the reservoir. Also included are the form required to ensure compliance for any new construction (3.2.2 Watershed Building Permit), identification of potentially hazardous chemical sites and a flyer for an event on forest management hosted by DEEP that included consideration of effects on water. 3.2.2 Manure Management is a flyer distributed to farmers in the watershed to ensure its protection.

Documentation Details: Windham Water Works oversees the largest watershed in Connecticut (166 square miles) that drains into the Willimantic Reservoir. They have developed plans to protect both of these resources. Central to these efforts was the hiring of an Environmental Technician (3.3.1 2022 Job Creation Environmental Technician). 3.3.1 Watershed Inspection Program details the steps taken to protect the watershed and 3.3.1 Hazardous Chemical Sites identifies Tier II sites that receive particular attention. 3.3.1 Watershed Sanitary Survey Report is the form used to collect data. New construction requires notification (3.3.1 Application for Construction in Watershed Areas) and MOU (3.3.1 MOU Source Water Protection from Runoff). An example of a completed inspection report is included (3.3.1 Inspection report). In addition, the reservoir has been protected with a riparian buffer (3.3.1 Reservoir Riparian Buffer) en decoys to deter geese (3.3.1 Reservoir Decoys). 3.3.1 Watershed Sanitary Survey Report details the activities undertaken to protect both the watershed and the reservoir and 3.3.2 2021 Water Quality Monitoring Report is specific to the reservoir. The ongoing regulations that have been enacted to protect these resources are evidenced in 3.3.2 Septic System Inspection Instructions as well as in the two reports. A log of septic system inspections for 2024 is included. Documentation Details: As detailed on the worksheet, Windham undertook an educational campaigns directed at reducing water usage for all residents but with a particular focus on youth. For students, a 5th grade field trip was held in January 2024 (3.7 5th grade field trip) and a class from of university students from ECSU visited in April (3.7 ECSU class trip).
