The school started a pilot food scrap diversion program in spring 2018, which has only expanded since then. The program collects over 1,300 pounds of food scraps per month and educates students on how to separate their food waste. Students sort their trash and food waste at a waste station in the cafeteria. The program also diverts prepackaged, unopened snacks, which are donated to the town senior center. The Woodbridge Ad Hoc Sustainability Committee, as well as Beecher Road staff, faculty, and parents, have developed and maintained this program.
