




Killingly achieved Bronze certification with 490 points in the fall of 2024.

Killingly supports affordable housing

Killingly is making strides in implementing strategies from its municipal affordable housing plan. The town recently hosted an informational meeting on Accessory Dwelling Units (ADUs), aiming to educate residents about how ADUs can increase housing options. Additionally, Killingly has provided zoning variances and permits, enabling higher -density developments to increase affordable housing availability. This includes specific units designed for special populations, ensuring that residents with diverse needs have access to supportive housing options.

Brownfield reclamation: a Killingly success story

killingly is actively advancing brownfield redevelopment efforts to enhance community spaces and safety. The town has completed a thorough inventory of brownfields, identified key sites for detailed environmental analyses, and committed American Rescue Plan Act (ARPA) funds to support the remediation process. This strategic use of resources will help transform underused or contaminated properties into productive areas.
